Some dimensions of aging grow and expand over time, while others decline. Reaction time, for example, may slow with age, while knowledge of world events and wisdom may expand. Research shows that even late in life potential exists for physical, mental, and social growth and development. Aging is an important part of all human societies reflecting the biological changes that occur, but also reflecting cultural and societal conventions. Human age is usually measured in full years. Caring for someone who is aging is very important, and this course provides descriptions of how to do this effectively.

Whether you are a parent a brother, aunt, uncle or grandparent, understanding autism and what it means for the person and their family assists with achieving the best outcome for all. "Autism for Families" is a short course designed to assist parents and other family members with understanding what autism is and how it affects their family member. While parents can become quite expert with regard to how autism affects their son or daughter, other members of the family can often be left out and sidelined. Everyone involved in the life of a person with autism has a role to play in supporting both the individual and the parents who are often isolated in their understanding and support of their child. By educating the whole family, individuals are more able to support each other and maximize the outcomes for all concerned. Training hours is approximately 5 hours.

Law and Ethics

Legal and ethical matters are of concern in almost every profession, especially in the field of mental health.
